DECMIL GROUP LIMITED SECURES CONTRACT TO BUILD VILLAGE ON MANUS ISLAND

Key points:

- **\$137 million contract for construction of village on Manus Island, PNG for Department of Immigration and Citizenship**
- **Expands geographic footprint with DGL's contract for the Manus Facility**
- **Demonstrates transferability of core skills and experience from building villages for Australian resources sector**

Leading design, civil engineering and construction company Decmil Group Limited (ASX: DCG) has been awarded a contract from the Commonwealth Government for the construction of a major accommodation facility on Manus Island in Papua New Guinea.

The \$137 million project is the first Commonwealth contract awarded to Decmil Group's wholly-owned subsidiary Decmil Australia.

It will see Decmil Australia utilise its skills built up over 30 years of constructing villages for Australia's iconic oil & gas and mining projects to build a 600 person accommodation facility for transferees comprising women, children, families and other vulnerable groups.

The project, the Manus Island Regional Processing Centre (MIRPC), is being built for the Department of Immigration and Citizenship.

In addition to the 600 person accommodation facility, the MIRPC will include:

- a 200 room accommodation facility for staff
- health, welfare, recreational and operational facilities, and
- associated engineering facilities and services.

Decmil Australia is preparing to mobilise and commence work on site in July 2013, with an anticipated completion of the project by 31 January 2014.

Decmil CEO Scott Criddle said: "This is a very significant win for Decmil Group for a number of reasons. It is a significant contract award and our first project for the Commonwealth of Australia.

"It is no secret that market conditions within the resources sector have been challenging over recent months. We are therefore delighted that we have secured this contract as it broadens the scope of work that Decmil is involved with on a number of fronts.
