## TWO NEW PROJECTS BOOST DECMIL CONTRACT ORDER BOOK BY \$36 MILLION

Decmil Group Limited (ASX: DCG) ("Decmil" or "Company") is pleased to announce a significant boost to its order book with two new projects in Queensland and Western Australia worth \$36 million.

The projects start within the next two months and Decmil will book first revenues this financial year.

The new projects bring Decmil's order book to \$411 million, \$254 million of which is with state government organisations.

In Western Australia, Decmil has been confirmed as a contractor on the Bayswater Station Metronet project by lead contractor Coleman Rail.

The project is a key part of the WA Government's Forrestfield Airport Link project, which connects Perth International Airport with Perth city and metropolitan area.

Decmil's component of the Bayswater project will be worth a minimum of \$25 million, with work expected to continue into FY22.

In Queensland, Decmil has been named preferred tenderer for an \$11.5 million contract by the Department of Transport and Main Roads Queensland for roadworks on the Bruce Highway.

Under the scope of the works, Decmil will undertake high-priority safety works including road widening, wide centreline treatment, barrier installation, clear zone clearing and culvert replacement and rehabilitation.

The project is located on the Bruce Highway in the section between Benaraby and Rockhampton, with work starting in May.

Decmil CEO Scott Criddle said the new projects underlined the strength of the Company's operational capability in infrastructure engineering and construction.

"These new projects are in Decmil's traditional areas of activity, where we have demonstrated great capability in project delivery and maintained strong, productive relationships with our valued customers," said Mr Criddle.

"Many of these customers are government departments and agencies, and we see enormous potential for expanding our presence in this market in the post-COVID environment as major infrastructure projects are fast tracked.

"The win in Queensland is significant in how it builds on our strong presence in the civil infrastructure space in Queensland.
