BOARD RENEWAL UPDATE

Decmil Group Limited (ASX: DCG) ("Decmil" or "Company") provides the following update on its board renewal program, which commenced on 29 June 2020.

As part of the renewal program's next steps, Decmil Chairman David Saxelby and Non-Executive Director Bill Healy have retired from the board. Mr Saxelby joined the board in 2016 and was appointed as chairman in March 2018. Mr Healy commenced as a Non-Executive Director in 2009.

The vacancies will be filled by Mr Peter Thomas and Mr Andrew Barclay, both of whom have considerable experience with both publicly listed companies as well as project development.

Mr Thomas is currently the Chief Financial Officer of Decmil and has held senior executive positions (including CEO and CFO) at Fortescue Metals Group, Adani Australia and the Balla Balla Infrastructure Group. Mr Thomas will continue as Chief Financial Officer of Decmil until the end of 2020 at which time a new CFO will be appointed.

Mr Barclay is an experienced legal practitioner and operates his own legal practice. Prior to this Mr Barclay was a partner at King & Wood Mallesons (formerly Mallesons Stephen Jaques) for 15 years, before working as senior legal counsel for the Fortescue Metals Group and Roy Hill. Mr Barclay has also been appointed Decmil Chairman.

"These board changes are another step in Decmil's rebuild," Mr Barclay said. "We expect to announce further board changes in the first six months of 2021 as we build out the board's expertise, governance and diversity."

"I would like to thank David and Bill for their efforts as non-executive directors of Decmil. They have both been dedicated board members providing counsel to senior management, Dave notably as Chairman for the past two years and Bill as a longstanding contributor to the Board of Directors for over a decade, including being the Chairman for a period. We wish them all the best in the future."

As both Mr Thomas and Mr Barclay have ongoing executive and advisory roles with Decmil, the further changes to the Board will include appropriate independent director appointments.
