OPERATIONAL UPDATE - INCLUDING \$27.8 MILLION IN NEW CONTRACTS

- Sunraysia Solar Farm receives "Full Output Operation Confirmation"
- Recently secured government Infrastructure contracts worth \$27.8M:
 - \$23.3 with Main Roads, Western Australia
 - \$4.5m with Queensland Department of Transport and Main Roads
- Ryan's Corner contract start date confirmed

Decmil Group Limited (ASX: DCG) ("**Decmil**" or "the **Company**") is pleased to provide the following operational update.

Sunraysia Solar Farm

Decmil is pleased to announce that following the completion of performance testing, the relevant authorities have confirmed that the Sunraysia Solar Farm has satisfactorily completed the required Hold Point testing (Comprising HP1, HP2 and HP3).

As a result, the Sunraysia Solar Farm has been approved for unconstrained operations (with a number of minor conditions to be addressed within the first three months of operation) and the formal process for obtaining Substantial Completion under the Contract has commenced and is expected to be achieved on or before 31 January 2022.

This will then enable conclusion of the EPC Contract and a transition into the Operation and Maintenance Contract.

The achievement of this milestone means the technical obligations of regulatory compliance of Sunraysia Solar Farm have been demonstrated and achieved.

Mitchell Freeway Principal Shared Path Award

Main Roads, Western Australia ("MRWA") has awarded Decmil a \$23.3 million contract for the construction of the Mitchell Freeway Principal Shared Path from Civic Place to Reid Highway, including the construction of an underpass at Karrinyup Road and intersection improvements at both Karrinyup Road and Cedric Street.

The Contract is expected to commence immediately and complete in September 2022.

The Contract was awarded through the State-wide Road Construction Panel, which Decmil was approved to join in FY21.

This latest award comes after Decmil secured the Great Eastern Highway contract at Coates Gully with MRWA in September 2021.

Capricorn Highway Award:

The Queensland Department of Transport and Main Roads ("**TMR**") has awarded Decmil a \$4.5 million contract to upgrade up to 5.1 kilometres of road on the Capricorn Highway between Emerald and Winton Creek.

The scope of work encompasses road widening, including earthworks, culvert extensions, pavement widening and overlay, and bitumen surfacing. The contract is scheduled for completion in June 2022.

Other projects Decmil has delivered or is delivering for TMR includes the recently completed Calliope River to Mt Larcom safety works contract during 2020/21; commencing a \$25 million Gin Gin to Benaraby road infrastructure project in March 2021; as well as the recent award of the Archer River contract (see ASX announcement 10 November 2021).

Ryan Corner Contract - Site Access:

Decmil has been advised by Ryan Corner Development Pty Ltd that the site access date will be Late January 2022.

Ryan Corner is a \$51 million balance of plant contract at the Ryan Corner Windfarm in Victoria. It was awarded in November 2020, however site access has been delayed throughout 2021. The contract will take approximately 12 months to complete.
